Event
WORLD AQUATICS SWIMMING CHAMPIONSHIPS (25M) - BEIJING 1st to 6th December 2026
Qualification Period
1st October 2025 to 1st October 2026
Selection Events
<p>Any World Aquatics 25m approved competitions (as per the World Aquatics list of approved events) within the above Qualification Period shall be considered a Selection Event.</p> <p><i>Note: While times for selection can be set at a range of meets, Clause 1.d. and 3.d. requires that, to be eligible for selection, Swimmers must compete at the 2026 NZ Short Course Swimming Championships, contesting the individual swimming event in which they are seeking selection in a committed and competitive manner, and that times achieved at the 2026 NZ Short Course Swimming Championships shall take priority.</i></p>

1. Eligibility

To be considered for selection, a Swimmer must:

- Be a New Zealand citizen who is eligible to represent New Zealand in competition as per World Aquatics Competition Regulations, Part One, Rule 3.
- Continuously be a registered and financial member of Swimming New Zealand (SNZ).
- Be a positive ambassador for SNZ.
- Compete at the 2026 NZ Short Course Swimming Championships, contesting the individual swimming event in which they are seeking selection in a committed and competitive manner.
- Comply with any established code of conduct or Swimmer agreement of SNZ and otherwise conduct themselves in a way that does not bring their sport or the team into disrepute.
- Have not used or administered any substance which, if it had been detected as being present in the Swimmer's body tissue or fluids, would have constituted doping, or used any prohibited method or committed any other doping offence as defined in swimming's anti-doping rules (including but not limited to World Aquatics and Swimming NZ).

2. Over-riding Selection Process

- a. The maximum team size will be in accordance with World Aquatics rules.
- b. New Zealand will enter a maximum of two Swimmers per individual swimming event at the World Championships (25m)
- c. Selectors will consider Swimmers for selection based on the Selection Standards below.
- d. In any decision regarding the selection of Swimmers, the Selectors may, in their sole discretion, consider any Extenuating Circumstances in accordance with Clause 6.
- e. Swimmers' selection will be announced no later than one week after the completion of the Qualification Period.

3. Individual Event Selection Standards

- a. An Individual Event is where a swimmer competes as an individual and not part of a relay team.
- b. To be considered for selection for an individual event, Swimmers must record a time equal to or better than the times detailed in Table 1 at a Selection Event in the Qualification Period *Note: These times will be the World Aquatics B times for 2026*).
- c. Heats, finals, and single gender relay lead-off splits in the relevant swimming event will be included in Selectors' consideration.

- d. **Ranking:** At the conclusion of the Qualification Period, each qualifying swim will be ranked in order of time fastest to slowest with times achieved at the NZ Short Course Swimming Championships taking priority followed by all other meets within the qualifying period. The first and second ranked Swimmers will be selected.
- e. **Tie Break:** Where times are equal for any second qualifying place, rank order will be determined using the Swimmers' times in the final of the relevant Individual Swimming Event at the 2026 NZ Short Course Swimming Championship. If there is still a tie for second place, rank order will be determined using a swim-off in the relevant event at a time during the 2026 NZ Short Course Swimming Championships agreed between the event management and the parties involved. Further swim-offs may take place until the tie is resolved.
- f. **Discretionary:** Where no eligible Swimmer has met Clause 3 for an individual event in Table 1, the SNZ Head Coach may recommend to the Selectors for consideration for selection the fastest eligible non-qualified Swimmer in the individual event at a Selection Event on the basis of prospects for the 2028 Olympic Games. Selection of any Head Coach's recommendation remains at the discretion of the Selectors.

4. Relay Event Selection Standards

- a. A Relay Event is where swimmers compete as part of a team relay and not as individuals.
- b. The Selectors will consider Swimmers for selection for the Relay Events indicated in Table 2 in alignment with the [World Aquatics Competition Regulations](#).
- c. Any Swimmer selected for an Individual Event must also be available for and may be selected to a Relay Event.
- d. Following consideration of Swimmers selected for Individual Events, the selectors will consider for selection swimmers for Relay Events who have recorded a time at a Selection Event in the Qualification Period, when combined with up to three other Swimmers who have recorded times at a Selection Event, to produce a composite qualifying time that is equal to or faster than the Relay Selection Standards in Table 2.
- e. For single gender relays, heats and finals in Individual Events, and splits from single gender Relay Events will be included in Selectors' consideration. For mixed gender relays, times in mixed gender Relay Events will also be included in Selectors' consideration.
- f. In considering the composite qualifying times, an allowance of approximately 0.6 seconds will typically be applied for consideration of relay changeovers.

- g. Swimmers being considered for Relay Events will be ranked in the same way that Swimmers being considered for Individual Events are ranked in Clauses 0 and 3.e.

- h. The final composition and order of any relay team will be determined from all selected Swimmers by the Head Coach at the event.

5. Additional Events

- a. Any Swimmer selected for an Individual or Relay Event may be able to swim additional events after consideration of the following criteria:
 - i. That there is a place available for them to swim in that Event.
 - ii. That by racing that Event, the performance of the Swimmer in the Individual or Relay Events that the Swimmer has been selected to swim will not be compromised.

6. Extenuating Circumstances

- a. In considering the selection of Swimmers in accordance with this Policy, the Selectors may, in their sole discretion, give weight to any Extenuating Circumstances which may include, but are not limited to, the following:
 - i. injury or illness;
 - ii. travel delays;
 - iii. equipment failure;
 - iv. bereavement or personal misfortune; and/or
 - v. any other factors reasonably considered by the Selectors to constitute extenuating circumstances.
- b. **Athlete to Advise:** Swimmers wishing for Extenuating Circumstances to be considered must personally and/or through a delegate advise the SNZ Head of High-Performance of the Extenuating Circumstances and reasons, in writing, with as much advance notice as possible and ideally seven (7) days prior to the 2026 New Zealand Swimming Championships. If the Head of High Performance is not notified of any Extenuating Circumstances, then the Selectors have no obligation to consider such circumstances.
- c. **Medical Certificate:** In the case of injury or illness, Swimmers may be required by the Head of High Performance to provide a medical certificate and/or to undergo an examination by a health practitioner/s nominated by the Head of High Performance, and to provide that opinion and/or report to the Selectors. Any failure to agree to such a request may result in the Selectors being unable to consider the injury or illness as an Extenuating Circumstance.
- d. **Return to Fitness:** Selection of any Swimmers in relation to Extenuating Circumstances, may be subject to conditions, such as satisfactory return to fitness. Such a process may or may not include a test in the swimming event that they have been selected for, with a target time by a given date, determined by the SNZ Head of High Performance and Head Coach.
- e. **Case by Case:** In the case of any Extenuating Circumstance/s, the Selectors will make a decision on a case-by-case basis.

7. Appeals

- a. **Grounds of Appeal:** A Swimmer may appeal non-selection on any one or more of the following grounds:

- i. That the applicable Nomination Criteria was not properly followed and/or implemented; or
 - ii. The Athlete was not afforded a reasonable opportunity to satisfy the applicable Nomination Criteria; or
 - iii. The nomination decision was affected by actual bias; or
 - iv. There was no material on which the nomination decision could reasonably be based.
- b. **Procedure for Appeals:** The procedure for a Selection Appeal shall be as follows:
 - i. A Swimmer wishing to appeal must give written notice of appeal to the SNZ Chief Executive within 48 hours of the selection announcement, stating their grounds for appeal.
 - ii. Within 48 hours of receipt of the appeal, the Chief Executive may propose a meeting between the parties and their representatives (if any) at which meeting the parties shall endeavour to resolve the appeal by discussion. Such a meeting, which may be held in person, by telephone or online, shall be held as soon as possible and in any event no later than 5 business days after the receipt of the appeal.
 - iii. Any such meeting shall be held on a confidential and without prejudice basis. In particular, the content of any matters discussed during such meeting may not be used by either party in respect of any further hearing of the appeal.
 - iv. If the appeal is not resolved at the meeting and the Swimmer wishes to proceed further with their appeal, the Swimmer must file an application for Appeal with the Sports Tribunal of New Zealand and serve a copy of such application for Appeal to the Chief Executive within 5 business days of the meeting or of the initial notice of appeal, whichever is later.
 - v. Appeals in the Sports Tribunal shall be determined in accordance with its Rules.
 - vi. The decision of the Sports Tribunal will be final and binding on the parties.

8. Notes

- a. SNZ may amend this Policy at any time, by giving reasonable notice to all Swimmers eligible for selection. Publication on the SNZ website will constitute reasonable notice.

WORLD AQUATICS SWIMMING CHAMPIONSHIPS (25M) BUDAPEST 2024 QUALIFICATION

The qualification for the World Aquatics Swimming Championships (25m) 2024 Budapest (HUN) is set out below. Entry times will only be accepted if they have been achieved at a World Aquatics-approved qualification event, either in a 25m pool or a 50m pool, within the period **23 July 2023 – 17 November 2024**. All times achieved outside this qualifying period will not be accepted. The Standard Entry Times for the World Aquatics Championships Doha 2024 will be applied as the standard times for 50m pool competitions.
